For example, you could trade-in your old car and receive a \$5,000 credit against the price of a \$10,000 new vehicle, making your out-of-pocket cost only \$5,000. In Georgia, the

taxable price of your new vehicle will be considered to be \$5,000, as the value of your trade-in is not subject to sales tax. This means that you save the sales taxes you would otherwise have paid on the \$5,000 value of your trade-in.

### Sales tax on cars and vehicles in Georgia

Generally, franchise dealers (or “ new car dealers ” ) are licensed through the vehicle manufacturers they work with, NOT through a Georgia state agency. Contact the manufacturers of the motor vehicles you plan to sell to begin your franchise agreement.
